

## **Australia's Biggest Meat Tray Raffle; Terms & Conditions**

### **1. Promoter**

The promoter is **Black Dog Institute** (ABN: 12 115 954 197 of Hospital Road, Randwick ("Promoter").

### **2. Promotion Name**

"Australia's Biggest Meat Tray Raffle" conducted in support of the **Mullets for Mental Health** fundraising campaign.

### **3. Promotion Period**

The promotion opens at April 21<sup>st</sup>, 2026 and closes April 30<sup>th</sup>, 11.59PM ("Promotion Period").

Entries received outside this period will not be accepted.

### **4. Eligibility**

- Entry is open to residents of Australia aged **18 years or older**.
- Entrants must purchase a valid raffle ticket during the Promotion Period.
- Employees of the Promoter and their immediate families are ineligible to win.
- Employees must abide by the laws and regulations of their state-based raffle laws and regulations.

### **5. How to Enter**

- Tickets are purchased online via official campaign fundraising pages.
- Each ticket purchased constitutes one (1) entry into the raffle to draw for the entrant's nominated state.
- Upon purchase, entrants will be allocated to a **state-based draw pool** based on their residential address.

### **6. Ticket Pricing**

- Ticket prices are set at \$10 per ticket.
- Multiple tickets may be purchased.
- All proceeds support the Promoter's mental health programs and services.

## **7. Prize Details**

- One (1) winner will be drawn per Australian state and/or territory (as determined by the Promoter).
- Each winner will receive:
  - One (1) “Meat Tray” prize, consisting of a selection of meat products or equivalent.
- Prize value per state: approximately AUD \$150.00-\$300.00.

## **8. Prize Conditions**

- Prizes are not transferable, exchangeable, or redeemable for cash.
- In the event a winner is vegetarian, vegan, or unable to accept the meat prize, the Promoter may, at its discretion, provide an alternative of equal or similar value.
- Delivery:
  - Prizes will be delivered to the winner’s nominated Australian address.
  - The Promoter is not responsible for delivery delays or issues outside its control.

## **9. Draw Details**

- The draw will take place in the week commencing May 4<sup>th</sup> 2026 electronically.
- The draw will be conducted randomly using an approved method.
- One (1) winner will be selected per state draw pool.

## **10. Winner Notification**

- Winners will be notified via email and/or phone within 21 days of the draw.
- Winners’ names may be published on the Promoter’s website and social media channels.

## **11. Unclaimed Prizes**

- If a prize is unclaimed after 14 days, the Promoter reserves the right to redraw the prize.

## **12. Use of Funds**

- Funds raised through ticket sales support the Promoter's mental health research, education, and support services.

### **13. Fundraiser Participation**

- Individuals participating as fundraisers are acting as supporters of the campaign.
- Fundraisers do not conduct the raffle themselves and are not responsible for prize fulfilment.
- All ticket sales are processed centrally by the Promoter.

### **14. Liability**

- To the extent permitted by law, the Promoter is not responsible for:
  - Technical issues affecting entry
  - Lost, late, or misdirected entries
  - Any injury, loss, or damage arising from participation in the promotion or use of the prize

### **15. Privacy**

- Personal information collected will be handled in accordance with the Promoter's Privacy Policy.
- Information will be used for the purpose of administering the promotion and may be used for future marketing communications (with consent).

### **16. Permits & Compliance**

- This promotion will be conducted in accordance with applicable laws and regulations in each Australian state and territory.
- Relevant permits will be obtained where required.

### **17. Changes to Promotion**

The Promoter reserves the right to:

- Modify, suspend, or cancel the promotion, if necessary, due to unforeseen circumstances
- Substitute prizes of equal or greater value if required
